## COVID-19 HEALTH & WELLNESS POLICIES AND PROCEDURES

### A ROCHA CANADA DAY CAMPS – PARENT INFORMATION & AGREEMENT FORM

Our goal is to provide children with a safe, healthy, fun, learning-filled camp experience. We want children, parents and staff who are part of the A Rocha community to feel confident that the Brooksdale Environmental Centre is as emotionally and physically safe as possible. We are committed to following guidelines set out by Child-Care Professionals of BC and the BC Government to protect health and wellness.

- Our Day Camps will be primarily outdoors where we are able to spread out and still stay connected.
- Camps will be capped at 18 participants. They will be in 3 smaller groups of no more than 6 children.
- Our staff are required to self assess daily for signs of infection, and to report infection within their social circle. If any signs are present in themselves, their family or social contacts, the staff will stay at home.

1. I will assess my child every day for cold, flu or COVID-19-like symptoms, even mild ones, such as fever, chills, cough, shortness of breath, sore throat and painful swallowing, stuffy or runny nose, loss of sense of smell, headache, muscle aches, fatigue or loss of appetite. I will also assess for other contagious illness related symptoms such as stomach flu and pink eye. I will commit to keep him or her home if any of these symptoms are present.
2. I will not send my child to camp if we are aware that he or she has been exposed to someone who has a positive diagnosis for COVID-19.
3. I confirm no one in our household has travelled outside of Canada in the last 14 days.
4. I will ensure that my child has everything that is needed prior to dropping them off in the morning.  
Example: Each child must bring his/her own stationery, lunch and water bottle.
5. I understand the drop-off and pick-up procedures.
6. Should my child develop symptoms while at camp, I will ensure someone is available to pick him/her up promptly if we are contacted by the staff to do so.
