A Rocha Boreal Ecology Centre Lodge Rental Agreement

By completing the Boreal Ecology Centre Lodge [rental request form](#), individuals and groups using the site and lodge agree to the following:

1. The Boreal Ecology Centre falls under a conservancy agreement requiring visitors to adhere to a strict code of stewardship.
 - a. No littering, destruction of wildlife or their habitat, peeling or cutting of trees, or picking or harvesting of flora.
 - b. No ATVs, snowmobiles, or other motorized recreational vehicles on site.
2. Smoking is not permitted on the premises.
 - a. Fires are permitted in designated pits only and are subject to all fire bans put in place by the Reynolds Municipality.
 - b. Fireworks are not allowed.
3. Groups renting the facility or visiting the premises are responsible for damages to equipment, buildings and site beyond normal wear and tear or unreasonable cleaning required due to the actions of the group.
 - a. Any damage to equipment, buildings or site should be reported to host.
4. Pets are not permitted.
5. Guests are responsible for bringing their own bedding, personal effects, and recreation equipment.
6. The Lodge can accommodate a maximum of 25 people.
7. Guests are expected to do some facility clean up prior to departure. Instructions are posted in the Lodge unless an additional cleaning fee has been arranged.
8. Reasonable cell phone signal is available on the grounds and in the Lodge, but Wi-Fi is not available.

9. A Rocha cannot assume responsibility for personal property and vehicles on the premises.
10. A Rocha complies with all public health guidelines. Please see restrictions for private residences prior to arrival and comply with all restrictions and guidelines. Guests will be asked to sign a compliance statement 1 week prior to their stay, while Covid 19 guidelines are in place.

Please Note:

Guests are responsible for bringing their own bedding, towels, and personal effects. While activities like snowshoeing or canoeing are allowed and encouraged, equipment is not provided at this time.

Guests are expected to do a basic facility clean up prior to departure.

Creation Care Guidelines for the Boreal Ecology Centre

1. Trails have been created for your enjoyment. Please remain on the trails in order to protect the area flora and fauna.
2. Motorized vehicles are not permitted on the trails.
3. Fires are permitted in designated sites only, within the fire pits provided.
4. The Boreal Ecology Centre follows all fire bans implemented by the Reynolds Municipality and Whiteshell Provincial Park.
5. We welcome and encourage you to take pictures and post to our [iNaturalist page](#). However, please do not pick or harvest any plants on site.
6. The cutting down of trees is not permitted.
7. Please refrain from bringing offsite firewood. Firewood has been provided for your use.

Please note:

Nature cameras have been installed along the paths in order to assist in documenting animal movement on site. Any pictures taken of individuals will be immediately deleted from files. Leave the cameras where and as they are.
